# SECTION 21 (A) ABSTRACTION OF WATER

### What constitutes as a Section 21 (a) water use?

Any water that is/will be utilised for operational purposes, these include water abstraction from

- Rivers (surface water)
- In-stream/ off-stream dams
- Boreholes (groundwater)

# When do you require an authorisation from the Department of Water and Sanitation?"

 Any water use that does not fall under a Schedule 1 Water Use (permissible use) requires either a General Authorisation (GA) or a full Water Use License Application (WULA) process.

### How would you know when you require a GA or a WULA?

Depending on the quaternary catchment within Southern Africa you are situated in, you have set limits/ volumes of allowable abstraction to fall under a General Authorisation (GN538) per quaternary catchment. Once these limits are exceeded you would be required to undertake full WULA.

The example snip-out to the right indicates the allowable volume that may be abstracted from surface water features within the "A" Quaternary Catchment under a General Authorisation.

Please Note - you still need to apply for a GA if the water use does not fall under a schedule 1.

# SECTION 21 (B) STORING OF WATER (CLEAN WATER)

#### What constitutes as a Section 21 (b) water use?

Any <u>clean</u> water that is used for commercial purposes, stored in:

- Off/ and In-stream Dams
- Reservoirs (steel and concrete materials)
- Jojo Tanks
- Earthen ponds

## When do you require an authorisation from the Department of Water and Sanitation?

 Any water use that does not fall under a Schedule 1 Water Use (permissible use- small jojo tanks used for household usage) may require a General Authorisation or a full Water Use License.

#### How would you know when you require a GA or a WULA?

Same as for Section 21 (a), depending on the quaternary catchment within Southern Africa you are situated in, you have set limits/volumes of allowable storage to fall under a General Authorisation (GN538) per quaternary catchment. Once these limits are exceeded you would require a full WULA.

The snip-out to the right indicates the allowable volume that may be stored by on each property/farm or by each person on communal land within the "A" Quaternary Catchment under a General Authorisation.

Please Note - you still need to apply for a GA if the water use does not fall under a schedule 1.
